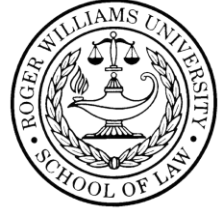

Joint Degree Requirements & Calendar

This worksheet is provided to assist you in selecting your courses in the joint degree program. However, it is your responsibility to confirm you have selected and enrolled in the appropriate courses to complete the program. In addition, the classes listed below are subject to change, and it is your responsibility to confirm the availability of a class each semester. **Please Note:** Semesters are indicated below for URI's courses; however, it is your responsibility to confirm that the class listed below is available during the semester you wish to take the course.

Calendar/Checklist

1L Year

RWU 1L, 1st Semester

- Visit the Marine Affairs Institute office
- Attend the joint degree program informational session
- Attend a session on experiential learning opportunities (note: it is recommended joint degree students do clinics and/or externships during their 2L year instead of their 3L year)
- Start to track curriculum with the below sheet

RWU 1L, 2nd Semester

- Set a meeting with Professor Wyman to discuss interest
- Track academic progress with curriculum sheet

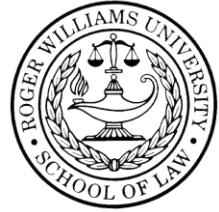
2L Year

RWU 2L, 1st Semester

- Meet with Associate Dean for Academic Affairs, Dean Brown, before applying to URI
- Meet with Financial Aid regarding the costs of an additional degree (note: scholarships **do not** transfer to the joint degree programs)
- Meet with Ann Marie Thompson from Student Finance and Records to discuss a course plan
- Attend the joint degree program information session for a second time
- Apply for RWU Law spring clinical opportunities during the application period
- Request transcripts and other necessary information through Parchment
- Prepare M.M.A. application and submit it to URI for the January 15th deadline (note: typically, you are notified of your admission status in the spring)
- Notify the Marine Affairs Institute once your application has been submitted
- Track academic progress with curriculum sheet

RWU 2L, 2nd Semester

- Notify Associate Dean Brown, the Office of Student Finance and Records, Financial Aid, and the Marine Affairs Institute of acceptance
- Revisit your planned course schedule to make sure you are on track for completing your required courses and reaching your required credit for RWU Law
- As soon as course schedules are available, select the courses you will need for both law and graduate programs
- Register for courses as soon as you are able
- Reach out to Financial Aid to make sure that the office is aware you will have joint degree credits, and discuss with them your financial aid package
- Track academic progress with curriculum sheet

3L Year

RWU 3L, 1st Semester

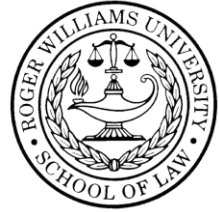
- MAF Orientation (at URI) – *mandatory*
- Financial Aid (loans) will be transferred from RWU Law to your graduate program, stay in regular contact with Financial Aid for your total credit load (both programs)
- Begin coursework at URI
- Begin consideration of major paper/project topic and advising professor
- Submit the Program of Study by the end of the first semester
- If appropriate, submit RWU transcript to URI
- Report any final exam conflicts between URI and RWU to RWU's Student Finance & Records and URI's Department of Marine Affairs
- Transfer credits at the end of each semester (note: this transfer should be done through the Office of Student Finance and Records)
- Track academic progress with curriculum sheet

RWU 3L, 2ND Semester

- Submit URI transcript to RWU
- Submit RWU transcript to URI
- Continue coursework at URI
- Report any final exam conflicts between URI and RWU to RWU's Student Finance & Records and URI's Department of Marine Affairs
- Transfer credits
- Track academic progress with curriculum sheet

Summer after 3L Year

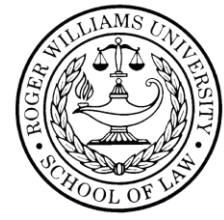
- Take the bar in your preferred jurisdiction

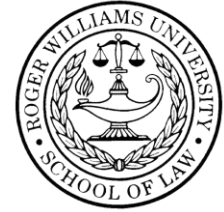

Other Requirements at RWU Law:

- Graduation Writing requirement (Law Review, Seminar, Directed Research)
- Experiential Education Elective Requirement (6 credits minimum, including LP3)
- Honors Perspectives (3 courses) *Honors Students
- 50 Hour Pro Bono Requirement (pre-approved, paperwork, Feinstein Institute)
- Joint Degree students are exempt from taking the four (4) bar courses, although it is highly recommended to take Business Organizations (note: students who started Fall 2023 or later are not required to take four bar electives but are required to take Business Organizations)
